

#### DRILL-FREE INSTALLATION

#### Note:

Apply and use 10°C-37°C (50°F-99°F).

Choose a spot where self-adhesive pads are not over grout lines.


Choose a flat, smooth surface, such as tile, glass, and metal.


DO NOT use on painted walls, textured walls, wallpaper, brick, fabric, lime walls, enamel varnish, and other rough and non-stick surface.



# 2 Remove backing carefully and avoid touching the adhesive surface.







#### TO REMOVE

#### STEP 1

Heat up the base plates with a hairdryer to soften the adhesive.

### STEP 2

Gently pry the base plates away from the wall with a plastic scraper.

#### STEP 3

Scratch or peel off any remaining adhesive.
